



## OFFICIAL RULES

### PROMOTION RULES

1. Participation in the Free Play Fast Break promotion (“Promotion”) is open to all Genting Rewards Members (“Participants”).
2. Participants may earn to play each level of the Promotion by playing at Resorts World Las Vegas between March 13 at 12:00 a.m. to March 19, 2023, at 11:59 p.m. and March 20, 2023 at 12:00 a.m. to March 26, 2023 at 11:59 p.m. (“Earning Period”).
3. Earning is based on Genting Base Points earned on slot machines. Multipliers will not apply.
4. Points earned during the first earning period (March 13-19) will not carry over into earning for the second earning period. (March 20-26)
5. Participants will have the opportunity to play a bonus game on their slot machine display once they reach each level of earning in the Promotion Structure.
6. The game will issue a random Free Play prize amount to the Participant, which will be loaded directly on to their account.
