

## OFFICIAL RULES

### GENTING REWARDS NEW MEMBER SIGN-UP BONUS RULES

#### PROMOTION RULES

1. Participation in the Genting Rewards New Member Sign-up Bonus ("Promotion") is open to individuals who are newly enrolled Genting Rewards Members ("Participants").
2. The Earning Period ("Earning Period") will occur at Resorts World Las Vegas starting from 12:01 a.m. on Wednesday, May 1, 2024, through 11:59 p.m. on Saturday, June 30, 2024.
3. Newly enrolled Genting Rewards members must have their first gaming or non-gaming transaction recorded to their Genting Rewards card ("First Rating Day") and earning completed within the same month, to be eligible for participation.
4. Participants can unlock a Free Play Bonus by earning a minimum of 1,000 Genting Base Points during the Earning Period.
5. Free Play bonuses vary from \$5 to \$500, depending on the Genting Base Points earned during the Earning Period. Please refer to rule #11 for the Free Play Prize Structure and earning requirements.
6. Earning is based on Genting Base Points earned on slot machines. Multipliers will not apply.
7. All prizes will be awarded in the form of Free Play.
8. Free Play Prizes may only be awarded once during the Promotion Period.
9. A Participant may only achieve each level once during the Promotion Period.
10. All Free Play prizes will expire thirty (30) days from date of distribution.
11. Official Free Play prize structure and earning requirements is as follows:

|---------|----------------------------|-----------------|
| Level 1 | 500                        | \$5             |
| Level 2 | 1,500                      | \$10            |
| Level 3 | 4,000                      | \$25            |
| Level 4 | 8,000                      | \$50            |
| Level 5 | 15,000                     | \$75            |
| Level 6 | 25,000                     | \$100           |
| Level 7 | 50,000                     | \$250           |
| Level 8 | 100,000                    | \$500           |
