

## \$15,000 APRIL SHOWERS DRAWING RULES

## **DRAWING RULES**

- 1. Participation in the Genting Rewards \$15,000 April Showers Drawing ("Promotion") is open to Genting Rewards Members who earn entry through casino play at Resorts World Las Vegas ("Participants").
- 2. The Promotion will take place at Resorts World Las Vegas beginning at 12:00 a.m. Tuesday, April 15, 2025, through 11:59 p.m. Thursday, April 17, 2025 ("Promotional Period").
- **3.** Participants must opt-in at either the Genting Rewards Club or the Resorts World Las Vegas Cashier & Loyalty Services Desk to be eligible for participation.
- **4.** Participants may earn drawing entries ("Drawing Entries") for a chance to win one (1) of fifteen (15) Free Play prizes. Prize details are specified in the Drawing Prize Structure.
- 5. Participants may earn Drawing Entries into the \$15,000 April Showers Drawing as follows:
  - 500 Genting Base Points = 1 Drawing Entry
  - 1,000 Genting Base Points = 5 Additional Drawing Entries
  - 2,000 Genting Base Points = 6 Additional Drawing Entries
  - 6,000 Genting Base Points = 24 Additional Drawing Entries

- **8.** The closing date of the Promotion entry is Thursday, April 17, 2025, at 11:59 p.m. Drawing Entries received outside of this time period will not be considered.
- **9.** Fifteen (15) Winners will be chosen from a random draw of Drawing Entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process. The draw will take place on Friday, April 18, 2025, at 10:00 a.m. ("Drawing Date").
- **10.** The winners will be notified via email and/or phone number provided in their Genting Rewards account by no later than Friday, April 18, 2025. Prizes may take up to one hour to be loaded to winners' accounts.
- **11.** The winner must confirm acceptance of the prize within twenty-four (24) hours of receiving the notification, or the prize will be forfeited.
- **12.** In the event that the winner forfeits the prize, an additional drawing will be conducted until a winner has confirmed both prize acceptance and address details.
- 13. All Free Play prizes will expire thirty (30) days from date of distribution.
- **14.** All prizes are non-exchangeable, non-transferable, and cannot be redeemed for cash or substituted for any other prizes.
