

## **GENTING REWARDS GOLD PROGRAM RULES**

- 1. Participation in the Genting Rewards Gold Program ("Promotion") is open exclusively to individuals who are active Genting Rewards members and at least fifty (50) years of age as of the date of participation ("Participants").
- **2.** All Participants are subject to the terms and conditions of the Genting Rewards membership program, as outlined in the official Genting Rewards Program Rules.
- **3.** Participants must present valid, unexpired government-issued photo identification upon request, for the purpose of age and identity verification.
- **4.** The Promotion will take place at Resorts World Las Vegas on Tuesday, beginning at 12:00 a.m. on Tuesday, June 3, 2025, and concluding at 11:59 p.m. on Tuesday, December 30, 2025 (the "Promotional Period").
- 5. Participants are eligible to receive up to \$25 in Free Slot Play on Tuesdays during the Promotional Period.
  - a. Free Slot Play will be awarded in variable denominations ranging from five dollars (\$5) to twenty-five dollars (\$25), based on the Participant's historical gaming and non-gaming transactions.
  - b. Newly enrolled Participants are eligible to receive a one-time Free Slot Play bonus in the amount of twenty-five dollars (\$25), pursuant to the Genting Rewards New Member Sign-Up Promotion.
  - c. Free Slot Play must be redeemed at an authorized Everi promotional kiosk.
  - d. Each Participant is eligible to receive a maximum of one (1) Free Slot Play Bonus per Tuesday during the Promotional Period. All Free Slot Play bonuses will expire five (5) days after issuance and will be deemed void thereafter.
- **6.** Eligible Participants shall receive a twenty percent (20%) discount at participating Resorts World Las Vegas retail outlets on Tuesdays only.
  - a. Retail discount is not combinable with other offers or promotions and is not valid on select merchandise, as determined at the sole discretion of management.
- 7. Additionally, Participants shall also be entitled to the following benefits:
  - a. A ten percent (10%) discount on food and beverage purchases at participating casual dining outlets.
    - i. Gratuities, taxes, and applicable fees are excluded.
    - ii. Verification of eligibility via government-issued ID and Genting Rewards card are required at the point of purchase.
- **8.** Resorts World Las Vegas is not responsible for any awards that are lost, delayed, misdirected, incomplete, or undelivered due to technical issues or other unforeseen circumstances.
- **9.** All awards granted through this Promotion are non-exchangeable, non-transferable, and cannot be redeemed for cash or other prizes.
