

GENTING REWARDS HONORS PROGRAM RULES

- 1. Participation in the Genting Rewards Honors Program ("Promotion") is open exclusively to Genting Rewards members who are active military personnel of the United States, including members of the Army National Guard, Air National Guard, Army Reserve, Navy Reserve, Marine Corps Reserve, Air Force Reserve, and Coast Guard Reserve. Veterans, retired military, prior service military, spouses of military personnel, first responders, which include law enforcement officers, paramedics, emergency medical technicians (EMTs), and firefighters are eligible (collectively, the "Participants").
- 2. All Participants are subject to the terms and conditions of the Genting Rewards membership program, as outlined in the official Genting Rewards Program Rules.
- **3.** Participants must be at least 21 years of age and must present a valid United States government-issued identification upon request to verify eligibility.
- **4.** The Promotion will take place at Resorts World Las Vegas on Thursdays, beginning at 12:00 a.m. on Thursday, May 29, 2025, and concluding at 11:59 p.m. on Thursday, December 25, 2025 (the "Promotional Period").
- 5. To qualify, Participants must present a valid U.S. driver's license or state-issued identification, along with one or more of the following credentials at the Genting Rewards Club: U.S. military ID, veteran's card, active military ID, National Guard ID, Reserve ID, Retired Military ID, Form DD-214, or any other valid documentation denoting military service. EMTs, paramedics, and firefighters may provide a state license, a certification issued within the past 48 months, or an ID card with their name and title. Law enforcement officers may present a valid ID card or a law enforcement officer (LEO) certification, issued within the past 48 months.
- **6.** Eligible Participants will receive a Genting Rewards Honors card, which includes an upgrade to the Genting Rewards Elite tier. Existing Genting Rewards members who already possess a tier status higher than Elite will receive 3,000 Tier Credits instead.
- 7. Any tier status upgrades or Tier Credits awarded under this Promotion will expire on Sunday, January 4, 2026.
- **8.** Participants will receive a \$10 weekly Food & Beverage credit, valid for single use and redeemable at participating casual dining outlets. This credit must be used within five (5) days of issuance.
- **9.** Additionally, Participants will be eligible for the following benefits:
 - a. A discount of up to 35% on military room rates at Resorts World Las Vegas.
 - b. Pre-sale access to Resorts World Las Vegas Theater show tickets.
 - c. A 10% military discount on Awana Spa services, valid Monday through Thursday, excluding holidays.
- **10.** Resorts World Las Vegas is not responsible for any awards that are lost, delayed, misdirected, incomplete, or undelivered due to technical issues or other unforeseen circumstances.
- **11.** All awards granted through this Promotion are non-exchangeable, non-transferable, and cannot be redeemed for cash or other prizes.

GENERAL RULES
