

## **2025 NEW MEMBER PROMOTION RULES**

## **PROMOTION RULES**

- **1.** Participation in the New Member Promotion ("Promotion") is open exclusively to individuals who enroll as new Genting Rewards Members ("Participants").

- **6.** Additionally, Participants must record their first gaming or non-gaming transaction ("First Rating Day") to their Genting Rewards account within the Promotional Period.
- **7.** Upon successful enrollment and completion of eligibility criteria, Participants shall be eligible to receive the new member incentive of \$25 in Slot Free Play.
- **8.** The Participant will need to wait for up to **24 hours** after successfully recording their First Rating Day, to receive the \$25 Slot Free Play new member incentive.
