

## PRIME TIME SWIPE AND WIN PROMOTION RULES



### PROMOTION RULES

1. Participation in the Prime Time Swipe and Win ("Promotion") is open to Genting Rewards Members who qualify through casino play at Resorts World Las Vegas ("Participants").
2. The Promotion will take place at Resorts World Las Vegas beginning at 12:01 a.m. through 11:59 p.m. each Wednesday during the month of August 2025 (each, a "Promotional Date"). The specific dates of the Promotion are as follows: August 6, 2025; August 13, 2025; August 20, 2025; and August 27, 2025 (collectively, the "Promotional Period").
3. Only Participants who are Prime, Monarch, Imperial and Crockfords Tier Level status are eligible to participate in the Promotion.
4. Eligible Participants may redeem a Mystery Free Play prize by swiping their Genting Rewards card at any designated Everi promotional kiosk located within Resorts World Las Vegas on a Promotional Date.
5. Prizes will be randomly generated by the promotional system and awarded based on the Participant's Tier Level status. The minimum and maximum values of Mystery Free Play prizes per Tier Level are as follows:
  - a. Crockfords Tier: \$10 – \$1,000
  - b. Imperial Tier: \$10 – \$1,000
  - c. Monarch Tier: \$10 – \$750
  - d. Prime Tier: \$10 – \$500
6. All prizes issued under this Promotion will be in the form of Free Slot Play and carry no cash value. Prizes may not be redeemed for cash, exchanged, or substituted.
