

## **WEDNESDAY WEEKLY STREET FEAST OFFER PROMOTION RULES (INVITED MEMBERS)**

### **PROMOTION RULES**

1. Participation in the Wednesday Weekly Street Feast Promotion (“Promotion”) is limited to invited individuals who are active Genting Rewards Members (“Participants”) at Resorts World Las Vegas. Eligibility is contingent upon qualifying casino play as determined by Resorts World Las Vegas.
2. The Promotion will take place at Resorts World Las Vegas beginning at 12:01 a.m. through 11:59 p.m. on select Wednesdays during the months of November and December 2025 (each, a “Promotional Date”). The specific Promotional Dates are as follows: November 5, 2025; November 12, 2025; November 19, 2025; November 26, 2025; December 3, 2025; December 10, 2025; December 17, 2025; and December 24, 2025 (collectively, the “Promotional Period”).
3. To receive a Street Feast prize, eligible Participants must swipe their Genting Rewards card at a designated Genting Rewards promotional kiosk on a Promotional Date.
