OFFICIAL TOURNAMENT RULES

TOURNAMENT RULES

1. Qualification into the \$60,000 Tuesday Slot Showdown Tournament (“Tournament”) is limited to guests that sign up for a Genting Rewards Card on the Tuesday of a scheduled slot tournament, Gen Gold 50+ Genting Rewards members, and Genting Rewards members that have earned one hundred (100) Genting Slot Base Points on the Tuesday of each of the scheduled Slot Tournaments.
2. The \$60,000 Tuesday Slot Showdown Tournament will be held every Tuesday from January 13, 2026, to March 31, 2026 (“Tournament Period.”).
3. Participants must be at least 21 years of age and be able to provide valid and current government issued identification.
4. There is no entry fee into this Tournament.
5. Gen Gold 50+ Genting Rewards Members and guests that sign up for a Genting Rewards card on the Tuesday of a scheduled tournament, will receive one (1) complimentary entry into the tournament for that day.
6. Genting Rewards Members can earn one (1) entry for every one hundred (100) Genting Slot Base Points earned on the Tuesday of each Slot Tournament. Table games points excluded.
7. Earning period will be every Tuesday from 12:00 a.m. to 3:30 p.m. during the Tournament Period.
8. A maximum of four (4) entries can be earned per Tournament Tuesday.
9. Gen Gold 50+ Genting Rewards Members and New Member sign-ups may qualify for a maximum of six (6) entries per Tuesday during the Tournament Period.
10. Participants are subject to all terms and conditions of Genting Rewards membership as outlined in the Genting Rewards rules.
11. Participants can print their earned vouchers at a Genting Rewards Promotional Kiosk from 11:00 a.m. to 3:45 p.m. on the Tuesday of a scheduled Tournament during the Tournament Period.
12. Tournament registration and Tournament play will be held every Tuesday from January 13, 2026, through March 31, 2026, from 11:00 a.m. - 4:00 p.m. at the Genting Rewards Club.
13. Upon Registration Participants will receive a PIN and walk-up to any open machine to redeem their entry.
14. Participants will play in one (1) 2- minute session, walk-up style at any time during the Tuesday Slot Tournament Play period.
15. Participants must be present at the Tournament Area and play the full round. A complete round must be played on a single machine. One (1) single Participant must play an entire round.
16. There is no smoking inside the Tournament Area.
17. A Participant's score is determined by the number of points registered on their assigned Tournament Machine at the end of their round, regardless of what the credit meter reads.
18. Tournament Machines have individual timers that may shut off upon malfunction. In the event a malfunction cannot be corrected, the Participant will be accommodated at Management's Discretion.
19. No money, tokens or coins will be required to play Tournament Machines.
20. The \$60,000 Tuesday Slot Showdown Tournament consists of one (1) two- 2-minute round per entry, as outlined in the Schedule of Events.
21. The \$60,000 Tuesday Slot Showdown Tournament rankings will be determined by the top score for each Participant and will be ranked from highest to lowest.
22. Free Play awarded will be credited directly to the Participant’s Genting Rewards account by 9:00 p.m. on each Tuesday of the scheduled tournament dates from Tuesday from January 13, 2026 – March 31, 2026.
23. If two (2) or more Participants have the same score total in the Tournament, the tied Participants will equally split the sum of the applicable prizes. For example, if three (3) Participants tie for 2nd place, they would equally split the 2nd, 3rd, and 4th place prizes; the next highest score would receive the 5th place prize amount.
24. The Prize Structure will be paid as published. A list of winning participants will be available at the Loyalty Services Desk by 9:00 p.m. on each Tuesday of the scheduled tournaments dates.

GENERAL RULES
