

FEBRUARY STREET FEAST OFFER PROMOTION RULES (INVITED MEMBERS)

PROMOTION RULES

1. Participation in the February Street Feast Promotion (“Promotion”) is limited to invited individuals who are active Genting Rewards Members (“Participants”) at Resorts World Las Vegas. Eligibility is contingent upon qualifying casino play as determined by Resorts World Las Vegas.
2. The Promotion will take place at Resorts World Las Vegas beginning at 12:01 a.m. through 11:59 p.m. on every Wednesday during the month of February 2026 (each, a “Promotional Date”). The specific Promotional Dates are as follows: February 4, 2026; February 11, 2026; February 18, 2026; and February 25, 2026 (collectively, the “Promotional Period”).
3. To receive a Promotion prize, eligible Participants must swipe their Genting Rewards card at a designated Genting Rewards promotional kiosk on a Promotional Date.
