

FEBRUARY STREET FEAST OFFER PROMOTION RULES (ALL MEMBERS)

PROMOTION RULES

1. Participation in the February Street Feast Offer (“Promotion”) is open to all Genting Rewards Members who qualify through casino play at Resorts World Las Vegas (“Participants”).
2. The Promotion will take place every day in February 2026 at Resorts World Las Vegas beginning at 12:01 a.m. through 11:59 p.m., February 1st, 2026 – February 28th, 2026 (each day, a “Promotional Date”).
3. To be eligible to receive a Promotion prize, Participants must (i) earn a minimum of seven hundred fifty (750) Genting Base Points through casino play on a Promotional Date, and (ii) swipe their Genting Rewards card at a designated Genting Rewards promotional kiosk on the same Promotional Date.
4. Upon meeting the participation requirements, each eligible Participant shall receive one (1) Street Feast Food Voucher valued at forty-five dollars (\$45).
5. All prizes will be issued in the form of Food and Beverage vouchers. Vouchers have no cash value and may not be redeemed, exchanged, or substituted for cash, chips, promotional play, or other form of value under any circumstances.
6. Each Participant is eligible to receive a maximum of one (1) Street Feast Food Voucher per Promotional Date in February 2026.
7. All Street Feast Food Vouchers issued pursuant to this Promotion shall expire twenty-four (24) hours from the time of issuance. Expired vouchers shall be deemed void and will not be honored under any circumstances.
8. Each (1) Street Feast Food Voucher valued at forty-five dollars (\$45) is a one-time use and cannot be used multiple times.
9. All Invited Members are ineligible to participate in this Promotion on Wednesdays during the months of February 2026 (each, a “Invited Members Promotional Date”). The specific Invited Members Promotional Dates are as follows: February 4, 2026; February 11, 2026; February 18, 2026; and February 25, 2026 (collectively, the “Promotional Period”).
10. All prizes shall be awarded to the primary Genting Rewards account holder who completed the kiosk swipe. Prizes are non-transferable, non-exchangeable, and cannot be assigned or gifted to another individual or entity.
