



## 2026 NEW MEMBER PROMOTION RULES

### PROMOTION RULES

1. Participation in the New Member Promotion ("Promotion") is open exclusively to individuals who enroll as new Genting Rewards Members ("Participants").
2. All Participants are subject to the terms and conditions of the Genting Rewards membership program, as outlined in the official Genting Rewards Program Rules.
3. Participants must be at least 21 years of age.
4. The Promotion will take place at Resorts World Las Vegas beginning at 12:01 a.m. (PT) on Friday, May 1, 2026, through 11:59 p.m. (PT) on Thursday, December 31, 2026 ("Promotional Period").
5. To participate in the Promotion, Participants must present a valid, unexpired government-issued photo identification at the Genting Rewards Club located at Resorts World Las Vegas and complete their enrollment into the Genting Rewards loyalty program during the Promotional Period ("Sign-up Date").
6. Participants must earn a minimum of three hundred (300) Genting Base Points within three (3) calendar days of their Sign-up Date to qualify for the Promotion.
7. Upon successful enrollment and satisfaction of all eligibility requirements, Participants will be eligible to receive a new member incentive of either twenty-five dollars (\$25) in Slot Free Play or twenty-five dollars (\$25) in Match Play.
8. Participants may claim their member incentive by swiping their Genting Rewards card at any designated Genting Rewards promotional kiosk and selecting either \$25 in Slot Free Play or \$25 in Match Play.
9. Participants may also earn additional prizes by accumulating additional Genting Base Points (excluding any slot point earning boosts) within three (3) calendar days of their Sign-up Date, according to the following thresholds:
  - a. **Upon earning 300 Genting Base Points:** Participants will receive the New Member Sign-Up Incentive of either twenty-five dollars (\$25) in Slot Free Play or twenty-five dollars (\$25) in Match Play.
