

MAY FREE PLAY BONUS BOUNCE BACK OFFER PROMOTION RULES



PROMOTION RULES

1. Participation in the May Free Play Bonus Bounce Back Offer Promotion (“Promotion”) is limited to invited individuals who are active Genting Rewards Members (“Participants”) at Resorts World Las Vegas. Eligibility is contingent upon qualifying casino play as determined by Resorts World Las Vegas.
2. The Promotion will be conducted at Resorts World Las Vegas from 12:01 a.m. on Monday, May 4, 2026, through 11:59 p.m. on Sunday, May 31, 2026 (the “Full Promotional Period”). The Promotion consists of four (4) individual promotional periods within the Full Promotional Period (each individually, the “Promotional Period”):
 - a. May 4 - 10, 2026
 - b. May 11 – 17, 2026
 - c. May 18 – 24, 2026
 - d. May 25 – 31, 2026.
3. To qualify for a Free Play Bonus Bounce Back offer, Participants must earn a minimum of one (1) Genting Base Point through casino slot play (excluding slot point-earning boosts) during the weekdays of Monday through Wednesday within each designated Promotional Period.

Upon meeting the earning requirement, eligible Participants must swipe their Genting Rewards card at a Genting Rewards promotional kiosk between Friday and Sunday of the same Promotional Period when Genting Base Point(s) were earned. Participants must then select the “Free Play Bonus Bounce Back Offer” to receive their Free Play bonus award.
5. Free Play bonus awards will be issued based on the Participant’s Genting Rewards gaming offer received in May 2026. Free Play bonus amounts will equal 50% of the Participant’s Genting Rewards May 2026 gaming offer.
