

JUNE BUNGALOW BASH DRAWING

PROMOTION RULES

1. Participation in the June Bungalow Bash Drawing (“Promotion”) is limited to Genting Rewards Members who obtain an entry through casino play at Resorts World Las Vegas and whose primary residence is located within a Clark County ZIP code beginning with the numerical range 890 through 891 (“Participants”).
2. The Promotion will take place at Resorts World Las Vegas beginning at 12:00 a.m. (PT) on Monday, June 1, 2026, and concluding at 11:59 p.m. (PT) on Tuesday, June 30, 2026 (“Promotional Period”).
3. To participate, eligible Participants must opt in to the Promotion by swiping their Genting Rewards card at any designated Genting Rewards Promotional Kiosk located on property during the Promotional Period.
4. Participants will receive one (1) drawing entry (“Entry”) for every one hundred (100) Genting Base Points earned through qualified casino play during the Promotional Period, unless otherwise specified herein.
5. From Tuesday, June 23, 2026, through Tuesday, June 30, 2026 (the “Bonus Entry Period”), Participants will earn ten (10) Entries for every one hundred (100) Genting Base Points earned through qualified casino play.
6. All Entries must be earned and credited no later than 11:59 p.m. (PT) on Tuesday, June 30, 2026. Entries earned outside the Promotional Period will be deemed ineligible and void.
7. Ten (10) potential winners will be selected in a random computerized drawing from among all eligible Entries received during the Promotional Period. The drawing will be conducted on or before Wednesday, July 1, 2026 (the “Drawing Date”).
8. Potential winners will be notified by email and/or telephone using the contact information on file in their Genting Rewards account no later than Wednesday, July 1, 2026.
9. Each potential winner must confirm acceptance of the prize within forty-eight (48) hours of notification. Failure to confirm acceptance will result in forfeiture of the prize.
10. In the event a prize is forfeited, an alternate winner will be selected through a subsequent random drawing from the remaining eligible Entries. This process will continue until all prizes are accepted and confirmed.
