

RED HOT MYSTERY POINT MULTIPLIER RULES

PROMOTION RULES

1. Participation in the Red Hot Mystery Point Multiplier Promotion (the "Promotion") is limited to active Genting Rewards Members ("Participants") whose primary residence is not located within a Clark County, Nevada ZIP code and who maintain a valid, confirmed hotel stay of at least one (1) room night at Resorts World Las Vegas during the Promotional Period.
2. The Promotion will take place at Resorts World Las Vegas beginning at 12:00 a.m. Pacific Time ("PT") on July 1, 2026, and shall conclude at 11:59 p.m. PT on August 31, 2026 ("Promotional Period").
3. During the Promotional Period, eligible Participants may receive up to four (4) additional Genting Bonus Points ("Bonus Points") for each one (1) Genting Bonus Point earned through qualified casino slot play (excluding slot point-earning boosts).
4. The Mystery Multiplier ("Multiplier") applicable to Bonus Points shall be generated and assigned randomly by the system. Participants may be awarded a multiplier of two (2), three (3), four (4), or five (5) times the number of Genting Bonus Points earned, as determined solely and exclusively by the system.
5. To participate, eligible Participants must, upon verification of hotel check-in, swipe their Genting Rewards card at a designated Genting Rewards promotional kiosk during the Promotional Period. Participants must then select and play the "Red Hot Scratch Off" game to reveal and activate their assigned Mystery Multiplier.
6. All Bonus Points earned in connection with the Promotion shall be credited to the Participant's primary Genting Rewards account no later than 12:01 a.m. PT on the calendar day immediately following the applicable date of qualifying casino play.
7. Once issued, the Multiplier shall remain valid for up to twenty-four (24) hours from the time of issuance. Upon expiration, Participants may become eligible to obtain an additional Multiplier, provided they continue to maintain an active in-house hotel stay of at least one (1) additional room night at Resorts World Las Vegas.
