

\$20,000 FALL KICK-OFF DRAWING

PROMOTION RULES

1. Participation in the \$20,000 Fall Kick-Off Drawing ("Promotion") is open to Genting Rewards Members who qualify through casino play at Resorts World Las Vegas ("Participants").
2. The Promotion will take place at Resorts World Las Vegas beginning at 12:00 a.m. (PT) on Tuesday, September 1, 2026, and concluding at 11:59 p.m. (PT) on Wednesday, September 30, 2026 ("Promotional Period").
3. To participate, eligible Participants must opt in to the Promotion by swiping their Genting Rewards card at any designated Genting Rewards Promotional Kiosk located on property during the Promotional Period.
4. Participants will receive one (1) drawing entry ("Entry") for every one hundred (100) Genting Base Points earned through qualified casino play during the Promotional Period, unless otherwise specified herein.
5. From Tuesday, September 1, 2026, through Monday, September 7, 2026 (the "Bonus Entry Period"), Participants will earn ten (10) Entries for every one hundred (100) Genting Base Points earned through qualified casino play.
6. All Entries must be earned and credited no later than 11:59 p.m. (PT) on Wednesday, September 30, 2026. Entries earned outside the Promotional Period will be deemed ineligible and void.
7. Twenty (20) potential winners will be selected in a random computerized drawing from among all eligible Entries received during the Promotional Period. The drawing will be conducted on Thursday, October 1, 2026 (the "Drawing Date").
8. Potential winners will be notified by email and/or telephone using the contact information on file in their Genting Rewards account no later than Thursday, October 1, 2026.
9. Each potential winner must confirm acceptance of the prize within forty-eight (48) hours of notification. Failure to confirm acceptance will result in forfeiture of the prize.
10. In the event a prize is forfeited, an alternate winner will be selected through a subsequent random drawing from the remaining eligible Entries. This process will continue until all prizes are accepted and confirmed.

12. Any Free Slot Play or Free Bet awarded pursuant to this Promotion must be activated and utilized no later than 11:59 p.m. on Saturday, October 31, 2026 ("Redemption Period").
13. Once the Free Play is activated, it must be used within five (5) days. Any unused Free Play remaining after the expiration date will be forfeited.
14. Once the Free Bet voucher is printed, it must be used within 48 hours after voucher printing. Any unused Free Bet vouchers shall expire within 48 hours after voucher printing.
15. Free Bet is valid for one-time use on even-money bets at designated tables. Free Bet cannot be combined with other promotions, discounts, offers or special events.

16. All prizes are issued exclusively as Free Slot Play or Free Bet and hold no cash value. Free Slot Play or Free Bet cannot be redeemed for cash and is non-transferable, non-exchangeable, and cannot be assigned or gifted to another individual or entity.
